I/We hereby waive, release, absolve, indemnify and agree to hold harmless the local Little League, Little League Baseball, Incorporated, the organizers, sponsors, participants and persons transporting my/our child to and from activities, for any claim arising out of an injury to my/our child, whether the result of negligence or any other cause, except to the extent and in the amount covered by accident or liability insurance.
4. I/We agree to replace any damage Little League equipment caused by the above candidate except those caused by normal wear and tear
5. I/We will furnish a certified birth certificate of the above candidate to League Officials.
6. I/We are aware of the Little League rules that requires that the player must reside or attend school within the boundaries of this League. I understand the rule and it's resulting consequences if not complied with.
7. I/We assure this League that the address and/or school shown on this registration form is that of my child's legal residence/school and that the address or school shown is within the boundaries of Aiea Little League.
8. 1. The primary purpose of this program is to develop good citizens. The actions and behaviors of the managers, coaches, parents and supporters should reflect the ideals of this objective. This program also provides our youngsters with the opportunity to have fun, learn the fundamentals of baseball and practice good sportsmanship.
2. Any verbal abuse directed at the umpires by coaches, parents and players will not be tolerated. The responsible party will be asked to leave the park, failure to comply will result in forfeiture of the game by the associated team.
3. Any verbal abuse or any physical abuse will not be directed to any youngster by the coaches, parents or other spectators. The responsible party will be asked to leave the park, failure to comply with result in forfeiture of the game by the associated team. Additional measures will be taken as deemed necessary by the League Director and the Board of Directors.
4. Arguments, harassment or fighting or not acceptable behaviors by any parties present at the ballpark. Policy should be called to address unruly behavior. Additional measures will be taken by the League Director and the Board of Directors.
